## **Introductions/Announcements**

- Lesley Shore announced several updates, the Annual Children's Wellness Family Fair on May 5<sup>th</sup>, several workshops, 80 vendors, activities, and "Free" transportation provided by Everett Transit. Asked if everyone could put a poster in there agencies. Three-Day training was just completed with 30 agencies for "Train the Trainer" to be trauma informed and support will be provided. Snohomish County Sales Tax Board just approved adding more schools to be trauma informed.
- Joe Neigel spoke about the website snocochildrenswellnesscoalition.com content has been added, care partners tab you can access interactive forum, and download sliders. The hope is to use it as an information exchange. Liza shared the meaning of the CARE acronym and spoke about (TILT) Trauma Informed Leadership Team, the module will be ready today and added to website. Members can create content just send information to Joe Neigel.
- Barbara Menzel mentioned services available at the Dispute Resolution Center, spoke about coparenting classes, trauma classes, and new programs. Next week a 2-day training at Cascade High School as a Pilot program for substitute for Detention. Barbara praised Joe Neigel and Liza on a great website.
- Community Health Center has a new facility off Rucker and 41<sup>st</sup> in Everett, Primary care and Walk-in are available.

## SEIN Task Force of Snohomish County and the work they are doing in our County

 Laura Mote introduced the presenter Lindsay Cortes, coordinator for the Sexual Exploitation Intervention Network. Center has started screening tools being used at Denney. Prevention tools taught at Denney would also be brought forward to schools. Covered Federal (Human Trafficking) and WA State (CSAM) Definitions – members participated in a quick activity. Graphs showed number of Minors Charged with Prostitution vs. Men trying to buy sex from minors from 2009-2016. An activity sheet was passed out for all to participate and have a better understanding of program. Prevalence Rates has limited data, numbers are difficult to collect in order to collect funding for program. On May 4<sup>th</sup>, a speaker with "Idealist" from Organization for Prostitution Survivors will offer a presentation.
