Introductions/Announcements

- Liza Patchen-Short welcomed all attendees, guest and introductions were made.
- Liza Patchen-Short spoke about today's activities. Members today will be working on **FINAL** updates and revisions for the Standard of Practice Form and Front page.
- Liza Patchen-Short mentioned there are 30 organization which are looking forward to becoming Trauma Informed, some have completed their training and have decals posted in their offices. Liza asked Nathan and Peggy Ray to talk about any highlights within their organization CARE Community.
- Liza Patchen-Short reminded all about the Youth and Family Wellness Fair on Saturday, May 4th at Evergreen Middle School. Anyone is welcome to join the planning team which meets once a month at Sisters and runs September through April.
- Liza Patchen-Short asked all members to group into triads and review this FINAL draft for discussion, edits and revisions.
- Liza Patchen-Short mentioned today's agenda is to make a motion to adopt SOP in Snohomish County and Goals for 2019.

REVIEW ITEMS and COMMENTS:

- Nathan Ray mentioned there are 3 places where there are still statements rather than questions, 3b, 3j, 9c. 4b is missing a period. 5b possibly using another word (clear process).
- Peggy Ray suggested this document have a revision date.
- Peggy Ray mentioned at the top of form #3 and #2 be changed to “We have started implementation” and #4 “We’ve made significant process.”
- Desmond Pullen mentioned 1i, how is that done? And 9c possibly go together?
- Nathan Ray mentioned why is there no Section 8?
- Lindsey Greene suggested a comment box at bottom of form.
- Kaitlin Davis suggested document should be tailored to the population you are serving and should be internal assessment document which does not need to be shared.
- Liza Patchen-Short mentioned the Care logo needs to be replaced with the Wellness Coalition logo.
- Liza Patchen-Short pointed out 3a. Putting “near” (spell out), and 6b. Recommend that it read “direct staff understand the signs, symptoms, and risks of suicide and are able to respond appropriately and get help.
- Sadie Nelson suggested a Definitions page? Any volunteers?
- Laura Mote mentioned “TILT” teams should have different levels of seniority. #4 should also be an annual expectation.
- 10e. suggest using “Internal Data” or “Data” instead of Organization Data, 10h. What is being said? Organizational Cultural.
- Sue McCarthy suggested changing 9c. To Organization.
- Desmond Pullen mentioned adding 3a. To “Core Training” includes Diversity and Equity, possibly add to Social Media.
- Sue McCarthy suggested adding Volunteers to the document? Encourage volunteers to participate.
- Peggy Ray suggested changing name to “Self-Assessment Tool”?
- Liza Patchen-Short mentioned a **FINAL DRAFT** copy will be sent out before finalizing.

ACTION ITEM. Laura Patchen-Short made a motion to approve and adopt the SOP (Standard of Practice for Trauma Informed Organizations). Nathan Ray seconded the motion. Motion passed.
