## Introductions/Announcements

- Liza Patchen-Short welcomed all attendees, guest and introductions were made.
- Liza Patchen-Short asked all to share their Updates and Highlights.
- Kaitlin Davis mentioned their organization is looking to hire a therapist.
- Sadie Nelson mentioned their offering another screening of "Biology of Stress and Science" in mid-September and Stars credits will be offered. 6:30-8:00PM at Snohomish Health District.
- Timothy Jackson mentioned there agency is working on module in order to train all staff.
- Liza Patchen-Short mentioned a Marketing strategy is being developed.
- Joe Neigel will be speaking about the website: snocochildrenswellnesscoalition.com which is up and running. Joe Neigel mentioned there are given out Admin rights if you are interested contact Liza Patchen-Short. The website is mobile compliance, user-friendly, and menu driven. - Joe Neigel spoke about the Coalitions goals from 2015 have been met and are looking forward to future goals for the next 3 years. Possibly access to data for 2019.
- Liza Patchen-Short mentioned next month's meeting will be two hours long and Mapping will be the topic.
- Liza Patchen-Short informed coalition that 23 schools are now trauma informed, 10 more schools will be added in future and moving forward with trauma informed.
- Joe Neigel mentioned there is a high suicide rate and would like to group to discuss on creating a Youth Focus Group at schools. What would the objective be? Would the coalition be interested in looking into creating these focus groups?
- Desmond Pullen asked the group to consider kids from shelters and other youth centers (Demey Youth, Cocoon House, etc.)
- Joe Neigel asked all members to break up in groups for around 10 minutes and talk about ideas and suggestions for this tip focus groups.

#### 10 Minute Group Session

- Joe Neigel asked for feedback from all tables. Each table went around and spoke of their ideas and suggestions for this group.
- Here are all topics that were discussed:
  - Reaching out to Work Source Development Center and SnoGlobe
  - Safe or Connected in School
  - What does Classroom looks like once classroom door is closed
  - Connect to Mentor or have access to one
  - Involve in Activities or outside Community groups
  - Making a Group of students to promote this group
  - Volunteering, Mentors, etc.
  - Cyber bullying
  - o MOU/ROI
  - Kids hanging out? Areas, friends, risks
  - Exploitation, Suicide, Mental Health
  - Parent Focus Group
  - English/Spanish Groups
  - Why kids are not reaching out? And was it helpful?
  - o Group to offer snacks, gift cards, incentives in order to get kids involved
  - Small sessions so child will trust you
  - Ongoing Advisory Panel
  - Open/Ended questions
  - Standardize age group 18-25 should also be included
  - Build trust with kids
  - o Weekly/Monthly meeting with same peer group
  - Personal/School Safety
  - Drug and Alcohol
  - Teen Focus Group
  - o Ongoing Advisory Panel

Joe Neigel thanked everyone for attending and is looking forward to make this focus group a reality.
