#### Introductions/Announcements

- Laura Mote welcomed all attendees, guest and introductions were made.
- Laura Mote gave a brief update on Liza Patchen-Short being out and her recovery.

- Laura Mote gave a brief explanation on the coalition to all new members and guests. Children's Wellness Coalition began around 3 years ago and main focus was schools. 23 schools are now Trauma Informed and in March of 2018 the coalition felt the community should also be trauma informed.
- Nate Marti gave a brief explanation about Resources/Inputs, Activities, Outputs, Outcomes/Impact.
